



## Welcome to the Lincoln Park Community Farm 2011 CSA Program.

**“Get Your Share Now!”**

I pledge to get my share. I would like to participate in the Lincoln Park Community Farm CSA for the 2011 growing season. As a member, I commit myself to supporting the Lincoln Park Community Farm with my ideas, input, and membership share. I have viewed the Lincoln Park Community Farm “Get Your Share” fact sheet describing the produce Lincoln Park Community Farm expects to grow, pick-up times and the expected times of harvest. I understand that shares are limited and available on a first come, first paid basis. The two share options available are: Full Share or Half Share

**Full share-** Pick up shares every week for all 4 weeks of the month.

**Half share-** Pick up shares on the 1<sup>st</sup> and 3<sup>rd</sup> week of the month.

I understand that in order to receive my share I must **pre-pay in full**

**Full Share-** Due First Wednesday of the month. Cost: **\$80**

**Half Share-** Due First Wednesday of the month. Cost: **\$40**

I understand that as a member of the CSA, I am expected to pick up according to my scheduled week. I commit to pick up, or send my representative to pick up, my weekly share on **ONE** of the agreed upon pick-up times. I understand that if I do not pick up my share it will be distributed to other members or given to the needy. I do not expect to have my share saved. I understand that the weather and other factors beyond the control of Lincoln Park Community Farm may result in more or less of these crops. I understand the shares will vary in size and weight depending on the season; they will be lightest early in the season. I understand that the varieties of produce and quantities listed are approximations of the produce I will receive and is highly dependent on growing conditions, weather, disease, insects, and other production factors that vary from season to season and that the risks and benefits of the harvest are shared by the members. I understand that I am investing in a fertile local farm that is dependent on normal weather conditions to be most productive. There is some risk of crop failure, which is minimized by growing a wide variety of crops, succession cropping, continued planting of crops, using earth boxes for drainage and irrigation of crops. I understand that all of the produce is selectively and harvested, but it is still possible that some insects and soil particles may be present, especially in rainy weather. It is your responsibility to wash thoroughly all of the produce you receive before consumption. I understand that homegrown produce unlike conventional produce is not always uniform in quality and appearance. I understand the produce has **NOT** been treated with fungicides after harvest like much conventional produce and simple bruising can result in spoiling.

I understand that this agreement will go into effect as of **July 6th, 2011**.
